RECOMMENDED ACTIONS

It is recommended that the Board review and adopt the revised Countywide Mission Statement and the mission and goals statements from the five areas of County government as recommended by the Board Policy Committees.

FISCAL IMPLICATIONS

There are no fiscal impacts which will result from adopting the recommended actions.

CONTRACT HISTORY

Not applicable.

REASONS FOR RECOMMENDATION

Annual review and adoption of the Countywide Mission fulfills the County Charter requirement. As well as fulfilling the charter requirement, the review of missions and goals is an annual procedure within the Comprehensive Performance Management (CPM) program. The review of mission and goals assures that County services are responding to the needs of the community and to the direction of the Board. In March the Countywide mission statement and each of the policy committee mission statements were reviewed. This transmittal packet contains the following mission statements:

- the current Countywide mission statement,
- the five revised Board policy Committee mission statements, and
- an addendum containing all of the agency and department mission statements

BACKGROUND

In June of 1997 the Board of Supervisors adopted a new Countywide Mission Statement. Throughout the year, this statement has served as a guide to County departments as they provide services to the residents of Santa Clara County. The Mission Statement has also been an assistance to departments in planning for the future.

The Board policy committee mission statements are used in the CPM program as a guideline for departments as they develop missions, goals and performance measures for all of their programs and service units. The mission and goal statements from the committees define in very broad terms the mission of County Government, "what we do", and the goals or results we hope to achieve through the services we provide to the community. After adoption last June, the policy committee mission statements were distributed to individual departments to insure that the department's missions and goals would remain in keeping with the expectations of the Board of Supervisors and the community.

CONSEQUENCES OF NEGATIVE ACTION

The County will continue to operate with the mission statement which was developed and adopted in 1997. The goals of individual policy committees may not accurately reflect the will of the Board of Supervisors or current governmental trends.

STEPS FOLLOWING APPROVAL

Provide one executed copy of the transmittal to the Office of the County Executive. The Office of the County Executive will then forward the Countywide Mission Statement and the policy committees missions and goals to the appropriate departments.

SANTA CLARA COUNTY MISSION AND GOALS

COUNTY WIDE MISSION

MISSION AND GOALS

SANTA CLARA VALLEY HEALTH MEDICAL CENTER

The Mission of Santa Clara Valley Medical Center is to provide:

 High quality, cost-effective medical care to all persons in Santa Clara County regardless of their ability to pay;

• a wide range of primary, secondary and tertiary inpatient, outpatients and emergency services within resource constraints;

 an environment within which the needs of our patients are paramount and where patients, their families and all our visitors are treated in a compassionate, supportive, friendly and dignified manner;

 A setting within which quality medical education and professional training are conducted for the welfare and benefit of our patients and community; and

 A workplace which recognizes and appreciates our employees and allows employees to realize their full work potential.

SCVMC STRATEGY:

The most effective way to assure that the health needs of all members of our community are met is the continued development of a viable health and hospital system under the County's auspices. This broad strategic position provides both maximum control of the County's resources and maximum public accountability.

The basic strategy for SCVMC has been defined since the early 1980's. It is to maintain and enhance the sponsored patient base of the health care system in order to maintain the open door to those who cannot afford to pay. The SCVMC's strategy can be outlined and summarized as follows:

Strategy #1: Pursue VMC's financial viability in the public interest. For a public hospital, the fundamental mission is to provide appropriate care to anyone who needs it, regardless of ability to pay. Fulfillment of this mission requires that the financial viability of the public hospital be pursued in order to maximize resources available to keep the doors open to the poor. Therefore, maintenance of programs and strategies to ensure the financial ability of the public hospital supports its basic mission and is in the public interest.

Strategy #2: Directly Provide and Control Hospital Services. The obligation to serve the medically indigent is most humanely and most effectively met by direct control of services provided. Through providing services, Santa Clara County can:

- Ensure that quality services are provided
- Ensure that people who need services get what they need
- Respond to changes in technology, medical science. and the marketplace by making decisions that directly affect the welfare of those for whom the County has an obligation
- Guarantee public accountability through locally elected public officials

Having decided to be a provider of care, the County of Santa Clara has many times faced critical decisions about how best to deliver health care services. Since 1854, when the first "pesthouse" (eventually to become the County Infirmary) was established through the decades of health care changes that occurred, Santa Clara County has repeatedly decided to reinforce its chosen role as provider through modernizing its facilities and continually improving its clinical and educational programs. These changes and decisions were made in each case in order to ensure access to care for all, strengthen programs and improve the quality of care. As the financing of health care has changed, the strategies employed by VMC have also changed to create and take advantage of significant streams of revenue, thereby assuring financial viability.

Strategy #3: Position delivery system for health care reform. "Reform" will affect providers in different ways. For VMC and the SCVHHS it means competing in targeted market "niches" or "at the margins", developing a continuum of care, continuing to expand primary care access, focusing on customer satisfaction, having the right balance of primary/secondary/tertiary care, continuing to focus on controlling costs, maintaining flexibility and ability in systems, and having attractive facilities. Irrespective of what shape health care reform takes over the next decade, a fully integrated system of care, including the presence of the County's public hospital, will guarantee access to all residents of the County to needed health care services and to improvement in the community health status.

Strategy #4: Build a system and a network of providers through relationships with community-based clinics and other private providers.

The hospital of the future is part of a system. The system of the future has a continuum of care, from prevention and education through primary and specialty outpatient care. routine and specialty hospital services and regional and tertiary inpatient services. The continuum of care is used to

manage the care of patients so as to control cost and promote wellness and needed treatment.

Community clinics are integral to the well being of the health care safety net in Santa Clara County. To that end, strengthening the network of relationships between the community clinics and SCVMC helps to bring together providers with like missions and commitment to serving vulnerable populations.

The system of care is also managed to maximize financial performance and viability of the overall system. During changing economic circumstances, the responses of the health and hospital system continue to depend in part upon the reimbursement mechanism in place, and depending upon the mix of patient populations for whom reimbursement methods differ.

Strategy #5: Plan for flexible facility uses in the future. With evolution of the health care system as described, facility planning should allow flexibility. Space may need reprogramming from one use to another. For instance, ability to switch from routine to intensive or transitional care levels, from acute to subacute, from inpatient to outpatient, and from one patient type to another (pediatric to adult, for example) without major remodeling, is an important plan component. In ambulatory settings, ability to relocate sites, expand quickly into new areas, or be mobile between communities is of high value in strategic planning and service delivery.

These strategies, undertaken by VMC, have kept the County's general fund contribution to a minimal amount while producing substantial revenues. This in turn has enabled the County to invest its general funds in non-hospital services.

BU 417 DEPARTMENT OF ALCOHOL AND DRUG SERVICES

Department Mission Statement

The mission of the Department of Alcohol and Drug Services is to provide the leadership and public accountability necessary to mobilize community resources to prevent and reduce the negative impact of substance abuse in the community.

Department Goals

- To develop comprehensive, integrated systems of care which are client-based and outcomefocussed
- To provide a climate in the community which supports a broad understanding of and a willingness to commit resources to the prevention and treatment of substance abuse.
- To develop a learning organization in which every action forms the basis for learning, improvement, and positive growth and change.

- Completed the first full year of the new managed system of care for adults.
- Developed and implemented a new training institute to provide education to the community regarding the substance abuse problem.

- Designed and initiated a new community-based substance abuse treatment continuum for adolescents and their families.

- Expand the managed system of care to address the new challenges of welfare reform.
- Complete the implementation of the adolescent substance abuse treatment continuum of care.

Submission of Revised Mission and Goal Statements:

Mental Health Department's Mission

The mission of the Santa Clara Valley mental Health Department is to enable individuals affected by mental illness and serious emotional disturbance to achieve the highest quality of life. To accomplish this, services must be delivered in the least restrictive, most accessible environment within a coordinated system of care, respectful of a person's family, language and culture.

Goals

The Department's Goal is to create a "best practice" service delivery model for Mental Health within available budget resources, that will meet the critical mental health needs of the diverse Santa Clara county residents. Central to this effort is a commitment to honor the vision and strategic planning recommendations of collaborative planning efforts of the past several years, and to insure that Mental Health providers, consumers and their families, and the Mental Health Board and other community advocates have a role as partners and stakeholders in a joint commitment to address community health and human service needs. Critical components of the system include the following Values:

- Age appropriate services for children, adults and seniors
- A single point of coordinated care for each client
- Client and family involvement in service planning
- Geographically accessible community based service
- A full array of service options

VISION

The vision of the Department of Public Health is to improve the health of the residents of Santa Clara County through leadership, mobilized community-wide planning, action, and advocacy.

MISSION

The mission of the Department of Public Health is to serve all people of Santa Clara County by protecting health; preventing disease, injury, premature death, and disability; promoting healthy lifestyles, behaviors, and environments; and responding to disasters and disease outbreaks and epidemics.

- development and/or advocacy of policies and legislation that improve health;
- · enforcement of laws and regulations that protect health and ensure safety; and

Children's Shelter and Custody Health Services BU 414

MISSION STATEMENT

The multidisciplinary medical and mental health practitioners in the Children's Shelter and Custody Health Facilities will provide medical and mental health care to all juveniles and adults residing in the Juvenile and Adult Custody Facilities. The medical and mental health care will focus on the prevention of illness, the control of preexisting pathologies, and the restoration to health once the detainee becomes compromised by illness.

The care rendered will be offered in an objective, non-judgmental environment and will be comparable to the quality provided in the general community. The practitioners will work interdependently, collaborating as necessary to ensure the well-being of the custody population.

- Obtain Correctional Treatment Center license for Main Jail Infirmary and the Mental Health Unit.
- Expand the scope of the inmate Self-Administration Medication Program to Medium Security Areas.
- Insure the prescription of atypical antipsychotic medications to all inmates who meet clinical criteria.
- Collaborate with designated members of County agencies in the development and implementation of a Jail Diversion Program.
- Further expansion of specialty ambulatory services at the County Jails.

- Contact each referred client promptly, screen each for financial eligibility and quickly undertake productive representation of those who qualify for services.
- Investigate cases in a manner and within a time period that will meaningfully assist the adjudication process, and provide each client with the level of services that is mandated by law.
- Provide effective defense to all clients so that constitutional rights are guaranteed, including the right to a fair trial.
- Administer resources wisely and promote efficiency in all office operations so that each client shall receive the service to which he is entitled by law.

83. The Chairperson announces Monday, January 27, 1997 at 1:30 p.m. as the date and time for closed session to discuss items noticed pursuant to the Brown Act.

On order of the Chairperson, there being no objection, the meeting is recessed at 1:50 p.m. to the State of the County Address from incoming Board of Supervisors Chairperson James T. Beall, Jr. at 6:00 p.m. this date.

Supervisor Beall states that the new year is a new beginning for Santa Clara County and expresses pride in advances in technology and developments in the area of public policy. Supervisor Beall refers to the County as one of the best managed counties in the nation and highlights increases in funding for domestic violence prevention, mental health jail diversion and the retiree health program and comments on the establishment of the drug courts. Supervisor Beall acknowledges Richard Wittenburg, County Executive, for his assistance.

Supervisor Beall indicates that two themes for the year are partnership and prevention and identifies the areas of transportation, crime prevention, public/private partnerships and welfare issues as priorities. Supervisor Beall expresses concerns relating to potential difficulties in obtaining adequate State funding for transportation, job training and child care.

Supervisor Beall continues by announcing the establishment of the following Board of Supervisors policy committees: Finance Committee; Children and Families Committee; Public Safety and Justice Committee; Health and Hospital Committee; and, Housing, Land Use, Environment, and Transportation Committee. Supervisor Beall additionally informs the Board, staff and audience members that some Board of Supervisors meetings will be held during evening hours and some will be held at neighborhood sites, with agendas and meeting materials available on the Internet at no cost.
