


#### CA kWh per capita vs. national average

# Business Energy Efficiency Incentives Programs

- Standard Performance Contract for accounts greater than 500 kW demand (Retrofit)
- Express Efficiency for accounts smaller than 500 kW demand (Prescriptive Retrofit)
- Savings by Design (New Construction)
- Energy Audits for large and small facilities

# County of Santa Clara Energy Efficiency Efforts

- Many Express Efficiency Projects from 1991 thru Now
- Express Efficiency 2001 Rebate \$ 235,000 for saving 3.4 Million kwh and 1,195 kw demand reduction
- This is equivalent to reducing 1,958 tons of carbon dioxide per year

## 2001 LED Traffic Lights

- Earned LED rebate of \$312,400
- Retrofitted 2,820 LED lamps and reduced
   1.3 million kwh electricity consumption and
   146 kw demand
- This is equivalent to annual 732 Tons Carbon dioxide emission reduction



## 2003 Chevron Energy Solutions

- Chevron audited County facilities in three groups
- SPC applications incentives assigned to Chevron
- Three group SPC applications for a total of \$56,700 are approved
- PG&E will review Chevron report for additional opportunities



### Future Opportunities

- Bench marking all County facilities and prioritize actions for retrofit opportunities and cost reductions
- "FREE" products under the Express Efficiency pilot from Sept 1 thru Dec 31, 2004 for eligible accounts
- Compact Fluorescent Lamps, LED Exit signs, Programmable Thermostats
- Vending Machine Controllers for additional cost of about \$50 each after the \$90 rebate
- Customer will install these products in 30 days
