RECOMMENDED ACTIONS

IT IS RECOMMENDED THAT THE BOARD OF SUPERVISORS.

- 1. ADOPT THE ATTACHED RESOLUTION ON THE INSTITUTION OF A VOLUNTARY PROGRAM FOR GASOLINE SALES.
- 2. DISTRIBUTE THIS RESOLUTION TO ALL CITIES IN SANTA CLARA COUNTY WITH THE RECOMMENDATION THAT EACH CITY ADOPT SAME.
- 3. DISTRIBUTE THIS RESOLUTION TO ALL NEIGHBORING COUNTIES TO INFORM THEM OF THIS ACTION.
- 4. COMMUNICATE WITH LOCAL FEDERAL LEGISLATORS TO INFORM THEM OF THIS ACTION, AND ON THE NEED TO PETITION THE U.S. DEPARTMENT OF ENERGY TO INSTITUTE A SYSTEM OF REGIONAL GASOLINE ALLOCATION.
- 5. COMMUNICATE WITH LOCAL STATE LEGISLATORS TO INFORM THEM OF THIS ACTION, AND ON THE NEED TO PETITION THE U.S. DEPARTMENT OF ENERGY TO INSTITUTE A SYSTEM OF REGIONAL GASOLINE ALLOCATION.

REASONS FOR RECOMMENDATIONS

THE SANTA CLARA COUNTY SERVICE STATION DEALER'S ASSOCIATION HAS ASKED THE BOARD OF SUPERVISORS FOR ASSISTANCE IN MITIGATING THE EFFECTS OF THE CURRENT GASOLINE SUPPLY/DEMAND IMBALANCE.

THE BOARD OF SUPERVISORS HAS A POLICY COMMITTING THE COUNTY TO PARTICIPATE IN ENERGY MANAGEMENT AND CONSERVATION EFFORTS.

THERE IS A PRECEDENT FOR LOCAL GOVERNMENT ACTION IN THIS SITUATION, TO WIT THE PROGRAM INSTITUTED FEBRUARY 28, 1974 FOR GASOLINE MARKETING.

BACKGROUND

LOCAL GASOLINE RETAILERS ARE RECEIVING ALLOCATIONS OF ONLY 85% to 95% OF THEIR SALES FOR THE SAME PERIOD IN 1978. SOME NON BRANDED RETAILERS FACE CUTBACKS OF AS MUCH AS 50%. SINCE 1978, COUNTY POPULATION, THE NUMBER OF REGISTERED VEHICLES AND THE LENGTH OF THE AVERAGE HOME/WORK COMMUTE HAVE RISEN SIGNIFICANTLY. THROUGH CONSERVATION EFFORTS, COUNTY MOTORISTS ACTUALLY DECREASED GASOLINE CONSUMPTION ABOUT 3% COUNTYWIDE FROM 1977 to 1978, BUT THERE REMAINS A SERIOUS SUPPLY/DEMAND IMBALANCE. THIS IS PROJECTED TO WORSEN AS THE SUMMER DRIVING SEASON APPROACHES. RECENT WEEKS HAVE SEEN LONG LINES AT GAS PUMPS, TRAFFIC CONGESTION, CURTAILED HOURS OF OPERATION AND SUNDAY CLOSINGS. GASOLINE RETAILERS HAVE REPORTED THAT MANY CUSTOMERS ARE MAKING PURCHASES OF LESS THAN FIVE GALLONS, SEVERAL TIMES A WEEK, IN AN EFFORT TO KEEP THEIR TANKS FULL AT ALL TIMES. THIS "TOPPING" HAS GREATLY INTENSIFIED THE CONGESTION AT THE GAS PUMPS, AND HAS CAUSED AN INREASONABLY QUICK DEPLETION OF THE DEALERS' DAILY RATION OF THE MONTH'S GASOLINE SEVERAL POTENTIALLY VIOLENT INCIDENTS HAVE BEEN REPORTED, RESULTS ALLOCATION. OF THE ANGER AND FRUSTRATION OF MOTORISTS TRYING TO GET GAS. THIS PLAN IS DESIGNED TO ALLEVIATE CONGESTION AT GAS STATIONS BY PROPOSING A VOLUNTARY PROGRAM OF ODD/EVEN ALLOCATION. SUCH A PLAN WAS INSTITUTED IN EARLY 1974 IN RESPONSE TO THE SUPPLY/DEMAND IMBALANCE OCCASIONED BY THE OPEC OIL EMBARGO. IT PROVED SUCCESSFUL THEN BY NOT ONLY RELIEVING CONGESTION, BUT BY REASSURING MOTORISTS THAT GASOLINE WOULD BE AVAILABLE TO THEM ON APPROPRIATE DAYS. AS THE FEAR OF AN EMPTY GAS TANK SUBSIDED, MOTORISTS STOPPED TOPPING TANKS THAT WERE MORE THAN HALF FULL AND RETAILERS WERE ABLE TO PROVIDE MORE DEPENDABLE SERVICE HOURS. THE SANTA CLARA COUNTY SERVICE STATION DEALER'S ASSOCIATION REQUESTED THAT THE COUNTY SUPPORT A PLAN FOR GASOLINE DISTRIBUTION, AND AFTER DISCUSSION BETWEEN THE ASSOCIATION, THE COUNTY OFFICE OF EMERGENCY SERVICES AND THE COUNTY ENERGY ADVISOR, THIS PLAN WAS PROPOSED. IT SHOULD BE NOTED THAT THIS VOLUNTARY PROGRAM IS UNDER THE AUSPICES OF THE SERVICE STATION DEALERS ASSOCATION, AND THAT THE COUNTY WILL NOT BE RESPONSIBLE FOR

CONSEQUENCES OF NEGATIVE ACTION

THERE WILL BE NO FORMAL COUNTY SUPPORT FOR THE SERVICE STATION DEALER'S ASSOCIATION VOLUNTARY PLAN FOR GASOLINE DISTRIBUTION.

RESOLUTION TO ESTABLISH A VOLUNTARY GASOLINE DISTRIBUTION PROGRAM IN SANTA CLARA COUNTY

WHEREAS, LOCAL GASOLINE RETAILERS ARE RECEIVING ALLOCATIONS OF ONLY 85% to 95% OF THEIR SALES FOR THE SAME PERIOD IN 1978; AND

WHEREAS, COUNTY POPULATION, NUMBER OF REGISTERED MOTOR VEHICLES, AND LENGTH OF AN AVERAGE DAILY COMMUTE HAVE ALL INCREASED SIGNIFICANTLY; AND

WHEREAS, MOTORISTS OF SANTA CLARA COUNTY ARE CURRENTLY EXPERIENCING CONSIDERABLE
DIFFICULTY OBTAINING GASOLINE, WITH EVERY INDICATION THAT THE SITUATION WILL WORSEN
IN THE COMING MONTHS; AND

WHEREAS, MOTORISTS, IN AN EFFORT TO ASSURE THAT THEY HAVE ADEQUATE GASOLINE, ARE
ATTEMPTING TO KEEP THEIR GAS TANKS CONSTANTLY FULL WITH MANY TRIPS TO THE GAS
STATIONS TO TOP OFF TANKS WITH PURCHASES OF LESS THAN FIVE GALLONS OF GASOLINE; AND

WHEREAS, THIS HAS RESULTED IN LONG LINES, REDUCED OPERATING HOURS, TRAFFIC CONGESTION, WASTED ENERGY SEARCHING FOR GASOLINE, IDLING IN LINES, ANGER AND FRUSTRATION; AND

WHEREAS, COUNTY MOTORISTS HAVE SHOWN THEIR COMMITMENT TO CONSERVATION OF TRANSPORTATION ENERGY AS DEMONSTRATED BY THE 3% DECLINE IN GASOLINE USAGE COUNTYWIDE FROM 1977 TO 1978; AND

WHEREAS, THE SERVICE STATION DEALERS ASSOCIATION HAS REQUESTED THE BOARD OF SUPERVISORS COOPERATION IN INSTITUTING A VOLUNTARY PLAN FOR GASOLINE SALES; AND

WHEREAS, THERE IS PRECEDENT FOR SUCH ACTION UNDER A PROGRAM UNDERTAKEN IN EARLY 1974
IN RESPONSE TO A SIMILAR GASOLINE ALLOCATION PROBLEM; AND

WHEREAS, THERE IS A FEDERAL STANDBY GASOLINE RATIONING PLAN WHICH COULD BE IMPOSED IF THE SITUATION BECOMES UNMANAGEABLE; AND

WHEREAS, IT IS PREFERABLE TO HAVE A VOLUNTARY, COOPERATIVE PROGRAM,

NOW, THEREFORE, BE IT RESOLVED THAT THE SANTA CLARA COUNTY BOARD OF SUPERVISORS DOES HEREBY SUPPORT THE SERVICE STATION DEALERS ASSOCIATION PROPOSAL FOR A VOLUNTARY PLAN FOR GASOLINE SALES; AND

BE IT FURTHER RESOLVED THAT THE BOARD URGES ALL CITIES IN SANTA CLARA COUNTY TO PARTICIPATE IN THIS VOLUNTARY PROGRAM; AND

BE IT FURTHER RESOLVED THAT THE PLAN, BASED ON THAT USED SUCCESSFULLY IN 1974, BE AS FOLLOWS:

AN "ODD-EVEN" SYSTEM FOR BUYING OF GASOLINE BE ESTABLISHED IN SANTA CLARA COUNTY AS FOLLOWS:

- (1) ANYONE DRIVING A MOTOR VEHICLE WITH A LICENSE NUMBER ENDING IN AN ODD NUMBER

 (1,3,5,etc.) or those who license plates which contain only LETTERS MAY BUY GAS

 ON ODD NUMBERED DAYS OF ANY MONTH (1st, 3rd, 5th, etc) E.G, SAM123; 123SAM;
- (2) THOSE WITH LICENSES ENDING IN EVEN NUMBERS (2,4,6,ETC.) SAM123, 123SAM.
- (3) ON THE 31ST DAY OF ANY MONTH ANY MOTORIST MAY BUY GAS.

EACH STATION SHOULD POST SIGNS OR FLAGS EASILY SEEN FROM THE STREET TO INDICATE IF IT IS SELLING GAS TO THE PUBLIC AT THAT TIME, OR IF IT IS OUT OF GAS OF CLASED. IF FLAGS ARE USED, GREEN SHALL MEAN "GAS FOR SALE," AND RED SHALL MEAN "NO GAS" OR CLOSED.

- (5) EACH STATION SHALL POST THE MINIMUM HOURS AND DAYS IT EXPECTS TO BE OPEN FOR GAS SALES ON A SIGN CLEARLY VISIBLE TO PASSING MOTORISTS.
- (6) EACH STATION OPERATOR SHALL MANAGE HIS/HER GAS SUPPLY SO THAT IT WILL LAST THROUGH THE MONTH, HE/SHE MAY ADJUST HOURS AND DAYS.
- (7) FOUR KINDS OF VEHICLES ARE EXEMPT FROM THESE RULES.

 THEY ARE:
 - A. EMERGENCY VEHICLES
 - B. BUSES REGULARLY USED TO TRANSPORT PASSENGERS.
 - C. VEHICLES WHICH A STATION OPERATOR BELIEVES ARE BEING USED FOR COMMERCIAL PURPOSES.
 - D. RENTAL CARS.
- (8) STATION OPERATORS MAY SELL GAS TO BE CARRIED AWAY IN CANS OR CONTAINERS ONLY WHEN THEY FEEL IT IS NECESSARY, AND IT SHALL BE THE SMALLEST AMOUNT THEY BELIEVE IS PRACTICAL.
